**CAMPGROUND RULES/REGULATIONS/PROCEDURES**

1. Rentals Monday thru Thursday. A check in the amount of \$500.00 must be remitted to secure the date of the rental. In addition, a check in the amount of \$100.00 must be remitted for security deposit. A check in the amount of your security deposit will be returned to you upon inspection of campgrounds after event.
2. Rentals Friday thru Sunday. A check in the amount of \$600.00 must be remitted to secure the date of the rental. In addition, a check in the amount of \$100.00 must be remitted to secure security deposit. A check in the amount of your security deposit will be returned to you upon inspection of campgrounds after event.
3. Multiple Day Rentals. A check in the amount of full rental fee must be remitted to secure the date of the rental. In addition, a separate check in the amount of \$100.00 must be remitted for security deposit. A check in the amount of your security deposit will be returned to you upon inspection of campgrounds after event.
4. Should your check not clear the bank for ANY reason, you will be required to make full restitution for the amount owed plus a service fee of \$40.00.
5. The individual or organization renting the campgrounds will be responsible for any damage to the campground and will make full restitution to the LOGGIA GIOSUE CARDUCCI LODGE NO. 146, INC.

6. All paper/debris must be disposed of by the renter at the end of the event. This includes all trash cans located inside the camp, restrooms, and those located outside the camp. A fee of \$25.00 per hour will be charged for failure to comply. A dumpster is on site for your convenience.
7. Picnic tables **MUST NOT BE MOVED!** Your deposit will be forfeited if this occurs!
8. The LOGGIA GIOSUE CARDUCCI LODGE NO. 146, INC. will not be held responsible for any lost or damaged items and/or personal injury. Renter assumes all personal injury liability of guests and attendees of event. This includes any hired contractors/agents/staff.
9. The individual or organization renting the campgrounds must secure and return with this Application an event policy – general liability coverage of no less than \$300,000.00 for the period that the campground is rented by the individual or organization which should include LOGGIA GIOSUE CARDUCCI LODGE NO. 146, INC. as an additional insured.
10. Individual or organization renting campground shall indemnify and/or hold harmless LOGGIA GIOSUE CARDUCCI LODGE NO. 146, INC. for all claims, actions and/or legal proceedings that may arise while said individual or organization is renting said campgrounds, including being responsible for the payment of attorney's fees on behalf of LOGGIA GIOSUE CARDUCCI LODGE NO. 146, INC.
11. This agreement is binding upon the heirs and assigns of the parties.
12. Anyone executing this agreement on behalf of any type of organization, verifies that he or she has full authority to bind said organization.
13. This agreement may only be modified in writing which is signed by all parties.

**CANCELLATION POLICY:** In the event of cancellation, notice of thirty (30) days or more will receive a refund of 50% of rental fee. A Notice less than thirty (30) day's **NO REFUND** of rental fee. In both cases, security deposit will be returned in full.
